

# Guernsey Travel and Visitor Annual Report

2025

The Guernsey Travel and Visitor Annual report provides information on travellers into and out of the Island of Guernsey during the year and additional analysis on visitor experiences from the Guernsey Visitor Survey.

## 1.1 Introduction


The Guernsey Travel and Visitor Annual report provides information on visitors to the Island of Guernsey, as well as Guernsey residents travelling to destinations outside the Bailiwick during 2025.

The information in this report is derived from passenger volume data which is collected monthly by Guernsey Ports and used to calibrate exit interviews conducted at the airport and harbour by fieldworkers. Occupancy information presented in this report is sourced from data provided by visitor accommodation providers. It should be noted that the passenger volume figures presented exclude travel between the Islands within the Bailiwick of Guernsey. Also, Herm, Sark and Alderney residents are only included in the analysis if they were in Guernsey “in transit” i.e. travelling via Guernsey to or from somewhere outside of the Bailiwick. For reporting purposes within this Bulletin, they are classified as Visitors and the purpose of their visit is classified as “Other” (along with residents of places outside the Bailiwick of Guernsey that were transiting through Guernsey on their way to or from a destination outside the Bailiwick).

In addition, this annual report includes information from the 2025 Visitor Survey which includes experiences of visitors to Guernsey, activities undertaken by visitors and their rationale and reasons for visiting Guernsey. Information from the 2025 Visitor Survey is based upon a much smaller sample of visitors; a subset of those that completed an exit interview with a fieldworker at the airport or harbour during 2025, who then also opted to self-complete an online Visitor Survey afterwards.

## 1.2 Headlines

**Figure 1.2.1 Passenger volumes - departing passengers**



COVID-19 related requirements were put in place for people travelling into Guernsey in February 2020 and remained in place throughout 2021 with no non-essential travel allowed between 12th March 2020 and 20th May 2020 or between 14th January 2021 and 22nd March 2021. The requirements varied depending on the country of origin and vaccination status of the traveller. All COVID-19 related travel restrictions were lifted on 17th February 2022, as can be seen in **Figure 1.2.1**. As such, comparisons in this report are mainly drawn between 2023 and 2024 throughout this bulletin.

## 1.2 Headlines (continued)

### All Passengers

- The total number of (resident and visiting) passengers (including any cruise and yacht passengers) departing Guernsey was 533,253 during 2025. This compares with 519,028 during 2024; an increase of 3%, but 5% lower than 2023.
- The number of passengers travelling by aeroplane in 2025 was 333,164 people; 2% higher than 2024 and broadly unchanged from 2023. The number of passengers travelling by ferry during 2025 was 151,718 people; 14% higher than 2024 and 18% higher than 2023. The number of cruise passengers was 28,397 people; 26% less than 2024 and 67% less than 2023. The number of visitors by yacht was 19,974 people; 3% higher than 2024 and 15% higher than 2023.

### Visitors


- The number of visitors that stayed in Guernsey for at least one night, but no more than 30 nights (having travelled by aeroplane and ferry) was 189,522 people in 2025; 4% higher than 2024 and 6% higher than 2023. Of these, 47% were here for leisure, 32% to see friends/family, 15% for business and 6% for other reasons.
- In 2025, 62% of all visitors staying in Guernsey stayed in hotels, (117,459 people), 25% stayed with friends/family (47,321 people) and 13% stayed in other accommodation (24,742 people).
- The average length of stay for staying visitors during 2025 was 4.6 nights compared with 4.9 nights in 2024 and 4.9 nights in 2023.
- Day trip visitors (who travelled by aeroplane and ferry) totalled 43,016 people in 2025, 31% higher than 2024 and 19% higher than 2023.
- In 2025, the number of visitors (including both cruise and yacht visitors) totalled 282,028 people. By country of residence, when compared with 2024, there were 1% more UK visitors, 7% more visitors from Jersey, 10% more visitors from the Rest of the World (visitor numbers were highest from Germany, Switzerland and the Netherlands) and 69% more visitors from France.
- The 2025 Visitor Survey asked leisure visitors *“Which of the following attracted you to visit Guernsey?”*. 85% of respondents cited that the natural beauty of the Island and its beaches attracted them to Guernsey. The second most popular reason was the history and heritage (56% of respondents). The third most popular reason was the proximity to Herm, Sark, Alderney and Jersey/ability to “Island hop” (31% of respondents). It also asked business travellers *“When you visited Guernsey, what type of business were you undertaking?”* and 36% said a small meeting/board meeting or similar.
- Results from the 2025 Visitor Survey indicate that the most popular activity (undertaken by 85% of all respondents during 2025) was eating and/or drinking out, followed by visiting sites of natural beauty (including beaches) at 72% and walking and/or running, undertaken by 62% of respondents. [Page 18](#) provides information on the most and least enjoyable aspects of survey respondents’ visits.
- The overall net promoter score for 2025 was 68 percentage points and compares with 55 percentage points in 2024 and 61 percentage points in 2023.

### Residents

- The total number of departing residents in 2025 was 248,513 people, 3% higher than 2024 and 4% higher than 2023. Of the residents, 184,026 travelled by aeroplane; 5% lower than 2024 and 4% lower than 2023. 64,487 people travelled by ferry; 33% higher than 2024 and 39% higher than 2023.

## 2.1 Passenger volumes

**Figure 2.1.1 Passenger volumes by mode of transport**



Data is collected by Guernsey Ports on the volumes of passengers travelling into and out of Guernsey. Just the volumes of passengers leaving the Island are presented here to represent the number of people (since most people have both outbound and return travel). It should be noted that these passenger volume figures exclude travel between the Islands within the Bailiwick of Guernsey. Herm, Sark and Alderney residents are only included in the analysis if they were in Guernsey “in transit” i.e. travelling via Guernsey to or from somewhere outside of the Bailiwick.

As shown in **Figure 2.1.1** the COVID-19 related travel requirements (which were put in place for people travelling into Guernsey in February 2020 and remained in place throughout 2021 with no non-essential travel allowed between 12th March 2020 and 20th May 2020 or between 14th January 2021 and 22nd March 2021) had a significant impact on passenger volumes. For this reason comparisons of passenger volumes are made with 2022 and years that were prior to the COVID-19 travel requirements. Total departing passengers in 2025, as shown in **Table 2.1.1**, was 533,253, 3% higher than 2024, but 5% lower than 2023.

62% of all departing passengers travelled by aeroplane in 2025, 333,164 people, 2% higher than 2024 and broadly unchanged from 2023. 28% of all passengers travelled by ferry in 2025, 151,718 people, 14% higher than 2024 and 18% higher than 2023.


## 2.2 Passenger volumes - destination

Data from Guernsey Ports is also available regarding the destinations of those travelling out of Guernsey by aeroplane and ferry. At present, the destination of those departing on cruise ships or yachts cannot be provided, but the total volume of departures is included for completeness.

**Figure 2.2.1** shows passenger volumes by destination, the COVID-19 related travel requirements (which were put in place for people travelling into Guernsey in February 2020 and remained in place throughout 2021 with no non-essential travel allowed between 12th March 2020 and 20th May 2020 or between 14th January 2021 and 22nd March 2021) had a significant impact on passenger volumes. For this reason comparisons of passenger volumes are made with 2022 and years that were prior to the COVID-19 travel requirements.

66% of all passengers departed Guernsey for the UK, totalling 350,533 people in 2025, 2% higher than 2024 and 1% higher than 2023. 11% of all passengers departing Guernsey were travelling to Jersey and totalled 58,762 people in 2025, 9% lower than 2024 and 8% lower than 2023. 14% of passengers departed Guernsey for the rest of the world and totalled 75,587 people in 2025, 41% higher than 2024 and 50% higher than 2023. 9% of passengers departed Guernsey on a cruise or yacht trip in 2025, 48,371 people, 16% lower than 2024 and 53% lower than 2023.

**Figure 2.2.1 Passenger volumes by destination**





## 2.3 Passenger volumes - residents and visitor

**Figure 2.3.1 Passenger volumes - visitors and residents by mode of transport**



Data is collected from passengers departing by aeroplane or ferry via a short interview-style survey. 8% of departing passengers were surveyed in 2025 (stratified by destination and port), which provides statistics with 95% confidence that they are accurate to within 1%. Survey results are applied to overall passenger volumes to give figures for the whole year.

One of the questions asked is whether travellers are resident in Guernsey or a visitor to the Island. It should be noted that within this Bulletin, Herm, Sark and Alderney residents are classified as Visitors. They are only included in the analysis if they were in Guernsey “in transit” i.e. travelling via Guernsey to or from somewhere outside of the Bailiwick (along with residents of places outside the Bailiwick of Guernsey that were transiting through Guernsey on their way to or from a destination outside the Bailiwick).

Prior to March 2020 surveys were conducted at the airport and harbour to determine the composition of passengers. When restrictions were put in place to reduce the impact of COVID-19 these surveys were suspended and the breakdown of passengers could not be determined. When the Travel Tracker system was introduced in late 2020, a limited amount of information about passengers could again be collected. However this was discontinued in February 2022.

## 2.3 Passenger volumes - residents and visitors


As shown in **Table 2.3.1** and **Figure 2.3.1**, 248,513 passengers, 47% of those departing Guernsey in 2025, were residents, whilst 53% of those departing Guernsey were visitors (282,028 passengers). Fewer than 1% (2,712 visitors) reported that they were returning to Guernsey later. In order to avoid duplication in sampling no further visitor information is collected from those passengers who report they are returning later and they are excluded from any subsequent analysis in this Bulletin.

At present, those departing on cruise ships or yachts are not asked to complete the same survey; within this report it is assumed that all passengers departing on cruise ships or yachts are visitors.


**Figure 2.3.2** shows the volume of visitors travelling by ferry, aeroplane, cruise ship and visiting yacht each year. In 2025, excluding those who visited by cruise ship, there were 253,631 visitors, 7% more than 2024 and 8% more visitors than 2023. 28,397 people travelled by cruise ship during 2025. The number of visitors travelling by aeroplane, 147,499 people in 2025, was 12% higher than 2024 and 9% higher than 2023. The number of visitors travelling by ferry in 2025, 86,157 people, was 2% higher than the number travelling by ferry in 2024 and 6% higher than 2023.

**Figure 2.3.3** shows the volume of residents travelling by ferry and aeroplane each year. The total number of departing residents in 2025 was 248,513; 3% higher than 2024 and 4% higher than 2023. In 2025, 74%, 184,026 residents travelled by aeroplane, the remainder, 26%, 64,487 residents travelled by ferry. The number of residents travelling by aeroplane in 2025 was 5% lower than the number travelling by aeroplane in 2024 and 4% lower than 2023. The number of residents travelling by ferry in 2025 was 33% higher than the number travelling by ferry in 2024 and 39% higher than the number travelling by ferry in 2023.

**Figure 2.3.2 Visitor passenger volumes**




**Figure 2.3.3 Resident passenger volumes**



\*When restrictions were put in place to reduce the impact of COVID-19, surveys of exiting passengers at the airport and harbour were suspended between Q1 2020 and Q1 2023. A limited amount of passenger information was collected from the Travel Tracker system which was in place between Q4 2020 and Q4 2021. In Q1 2023 exit surveys were re-instated and full passenger breakdowns could again be reported.

## 3.1 Visitors - main purpose of trip to Guernsey

**Figure 3.1.1 Visitors - main purpose of trip to Guernsey**



One of the questions asked of visitors during passenger exit surveys is what the main purpose of their trip to Guernsey is. Survey results are applied to overall passenger volumes to give figures for the whole year. At present, those departing on cruise ships or yachts are not asked to complete the same survey, but the overall number of these visitors is still included in this section for completeness.

In 2025, 112,181 visitors reported the main purpose of their trip to Guernsey was for leisure (109,249 in 2024, a 3% increase). 19,974 people visited by yacht during 2025, 3% more than 2024. 28,397 people visited by cruise ship, 26% less than 2024. 61,009 visitors cited they were seeing friends/family (60,722 in 2024), 37,276 were here for business (28,767 in 2024, a 30% increase) and 22,073 were here for other reasons (16,351 in 2024). Other reasons include visitors to Guernsey in transit, visitors on a school trip/visit, visitors in Guernsey for medical/hospital purposes and visitors participating in sport. 1,118 visitors during 2025 were long stay visitors, having stayed more than 30 nights but less than 1 year. The majority of long stay visitors were in Guernsey for work reasons.

64% of all visitors to Guernsey during 2025 said they had visited Guernsey before (the equivalent figure for 2024 was 63%).



## 3.2 Visitor Survey\* - what attracted leisure visitors to Guernsey


Leisure visitors (131 respondents in the survey in 2025) were asked “Which of the following attracted you to visit Guernsey?”. Percentages do not add up to 100% for this question as respondents were able to select more than one option. 85% of all leisure visitors in 2025 cited that the natural beauty of the Island and its beaches attracted them to Guernsey (85% in 2023, 83% in 2024), the second most popular reason was the history and heritage, 56% of respondents, (54% in 2023, 53% in 2024) and the third most popular reason was proximity to Herm, Sark, Alderney and Jersey / ability to “Island hop”, 31% of respondents (31% in 2023, 33% in 2024), as shown in **Figure 3.2.1**.

Leisure visitors were asked “To what extent did promotion of Guernsey influence your decision to visit?”. 21% of respondents reported that recommendation from friend(s)/family member(s) had a big influence on their decision to visit Guernsey. 13% of respondents reported that the visitguernsey.com website advertising the Islands of Guernsey had a big influence on their decision. 8% of respondents reported advertising by airlines or ferry operators had a big influence. Radio advertising was perceived as the least influential on leisure visitors’ decisions to visit Guernsey during 2025; 95% of respondents reported radio advertising had no influence, as shown in **Figure 3.2.2**.

**Figure 3.2.2 To what extent did promotion of Guernsey influence your decision to visit?**





Business travellers (50 respondents) were asked “When you visited Guernsey, what type of business were you undertaking?” 36% were attending a small meeting, board meeting or similar and 11% were attending a large meeting, conference or similar, as shown in **Table 3.3.1**. Of the 36% of business travellers who stated they were in Guernsey for other purposes, reasons given included for training, inspections, audits, job interviews and to undertake building work. Please note the analysis on business travellers presented on this page is based on very small sample sizes.

Business travellers were asked “How many times have you visited Guernsey in the past year on business?” An additional follow-up question was asked; “How many times have you visited Guernsey on business during the year before that?”

In the past year, 45% of business travellers had visited Guernsey once on business, compared with 42% the previous year, as shown in **Figure 3.3.1**. 31% of business travellers in 2025 had visited Guernsey two to four times on business, compared with 29% the previous year. 18% of business travellers in 2025 had visited Guernsey five to twelve times on business; in the previous year it was 26%. 6% of business travellers in the past year had visited Guernsey over twelve times on business, compared with 3% the previous year. As previously mentioned, these percentages should be treated with caution as they are based on a small sample.

### 3.4 Visitors (all) - country of residence and length of stay

Another of the questions asked of visitors during passenger exit surveys is their country of residence. Survey results are applied to overall passenger volumes to give figures for the whole year. At present, those departing on cruise ships or yachts are not asked to complete the same survey, but the overall number of these visitors is still included in this section for completeness.

During 2025, 54% of all visitors, 153,332 people reported their country of residence was the UK (55%, 152,166 in 2024). 10%, 28,029 visitors were from France (6%, 16,561 in 2024). 7%, 19,270 visitors were from Jersey (7%, 18,074 in 2024), 12%, 33,026 visitors were from the Rest of the world (11%, 30,102 in 2024), and 17%, 48,371 visitors' country of residence was unknown, as they were visiting by cruise ship or yacht (21%, 57,774 in 2024).

In 2025 there were 1% fewer visitors who reported their country of residence was the UK, when compared to 2023, but 1% more than 2024. 6% more visitors from Jersey, when compared to 2023 and 7% more than 2024. 88% more visitors from France than 2023 and 69% more than 2024. 13% more visitors from the Rest of the world, when compared to 2023 and 10% more than 2024 (in the Rest of the World category the highest number of visitors came from Germany, Switzerland and the Netherlands).

During 2025, 43,016 people visited Guernsey on a day trip, representing 15% of all visitors (32,804 people, 12% in 2024). The majority, 67% of visitors, 189,522 people, stayed at least one night but less than 31 nights (182,285 people, 66% in 2024). During 2025 less than 1% of visitors were long stay visitors (1,118 people).

Comparison between 2025, 2024 and 2023 reveals that in 2025 there were 6% more visitors staying at least one night (but less than 31 nights) than in 2023 and 4% more than 2024. In 2025 there were 19% more visitors on a day trip than in 2023 and 31% more than 2024. The average length of stay for visitors staying at least one night but less than 31 nights was 4.6 nights in 2025, equating to 866,278 bed nights, and compares with 4.9 nights, and 893,868 bed nights in 2024.

## 3.5 Visitors - net promoter score


Visitors leaving the Island by aeroplane or ferry are asked how likely they would be to recommend Guernsey to a friend or relative (as a score out of 10, with 10 meaning very likely) as part of the exit survey. Prior to 2020 net promoter scores did not include visitors whose country of residence was Alderney, as a high proportion of these passengers were in transit (returning via Guernsey to Alderney). Since Q1 2023 all passengers (regardless of country of residence) that are leaving the Island by aeroplane or ferry after only visiting Guernsey on their way to or from somewhere outside the Bailiwick (and, as such, potentially may not have left the port) are excluded from the net promoter scores analysis on this page. At present, those departing on cruise ships or yachts are not asked to complete the same survey and are not represented within the net promoter scores presented on this page.

The net promoter score (NPS) is calculated by deducting the percentage of visitors surveyed that gave a score of six or less out of ten from the percentage of visitors surveyed that gave a score of ten or nine out of ten.

As shown in **Table 3.5.1**, the overall net promoter score for 2025 was 68 percentage points and compares with a score of 55 percentage points in 2024 and 61 in 2023. Net promoter scores show some seasonality, tending to be lower in winter months (Q1 and Q4) and higher in summer months (Q2 and Q3). The increase in the NPS between 2024 and 2025 can be attributed to a higher proportion of visitors who gave a score of ten out of ten. For those who did give a score of ten they remarked that it is a beautiful island, friendly, very clean (with many noting the cleanliness of public amenities), has excellent restaurants, great beaches, feels safe, has a good bus service, and that attractions like La Vallette bathing pools, Guernsey museums, the Little Chapel and Hauteville house are excellent.

In 2025, themes from those who gave a score of six or less out of ten include they haven't seen much of the Island, found it expensive, experienced bad weather, there were too many roadworks/diversions, a lack of (open) visitor attractions, poor customer service and travel plans were disrupted.

**Figure 3.5.1 Net promoter score**





### 3.6 Visitor Survey\* - age and composition of groups of leisure visitors and those seeing friends and family

Based on responses to the online Visitor Survey, in 2025, 18% of leisure visitors and those seeing friends and family travelled alone (17% in 2023, 14% in 2024), 41% travelled to Guernsey as a couple or with their partner (48% in 2023, 47% in 2024) and 25% travelled with their family (24% in 2023, 26% in 2024), 10% travelled to Guernsey with friends (6% in 2023, 5% in 2024) as shown in **Figure 3.6.1**. Mixed group refers to a mixture of either a couple/partner, family and/or friends.

Respondents were also asked the age profile of their party in terms of the number of people in each age band. 51% of visitors during 2025 were aged 55 years and above (49% in 2023, 45% in 2024). 15% of visitors were aged under 25 years (14% in 2023, 18% in 2024), as shown in **Table 3.6.1**. 34% of visitors were aged between 25 years and 54 years during 2026 (36% in 2023 and 2024).

## 4.1 Visitors - accommodation of staying visitors

Visitors who stayed in Guernsey overnight are asked an extra question about the type of accommodation they stayed in as part of the exit survey. Survey results are applied to overall passenger volumes to give figures for the whole year. Those visitors staying in Guernsey more than 30 nights (long stay) are excluded from this analysis.


As shown in **Figure 4.1.2** and **Table 4.1.1**, in 2025, 62% of all visitors staying in Guernsey stayed in hotels, (117,459 people), 25% stayed with friends/family (47,321 people) and 13% stayed in other accommodation (24,742 people). The other category includes guest houses, any accommodation listed on Airbnb or other online booking portals, self-catering units and campsites etc. Comparison between 2025, 2024 and 2023 reveals that in 2025 the number of people staying in hotels was 8% higher than 2024 and 2023. During 2025 3% fewer visitors stayed in friend/family's homes than 2024, but 5% more than 2023. The number of visitors who stayed in Other accommodation was broadly unchanged, compared with 2024 and 2% lower than 2023.

On average visitors in hotels stayed 3.6 nights in 2025 and equates to 427,866 bed nights. During 2025 the average length of stay with friends/family was 5.8 nights, equating to 275,729 bed nights and the average length of stay in Other (which includes guest houses, any accommodation listed on Airbnb or other online booking portals, self-catering units and campsites etc) was 5.7 nights equating to 142,241 bed nights.



## 4.2 Visitor Survey\* - how staying visitors rated their accommodation

Visitors in Guernsey for business, leisure or seeing friends and family and other reasons staying in commercial accommodation in 2025 (216 respondents) were asked a number of questions regarding their accommodation whilst staying on Island. Results have been weighted by purpose of visit data from exit interviews to ensure that survey responses are representative of all visitors.


During 2025, 87% of visitors reported that the room quality and customer service level at their accommodation was high or very high (82% and 88% respectively in 2024). 86% of visitors reported that the overall standard of accommodation was high or very high (85% in 2024). 84% reported that island knowledge was high or very high (78% in 2024). 83% reported that the state of repair of building / garden at their accommodation was high or very high (82% in 2024). 80% of visitors reported that the food quality was high or very high (82% in 2024). 68% of visitors reported that the value for money of their accommodation was high or very high (65% in 2024), as shown in **Table 4.2.1** and **Figure 4.2.1**.



Leisure visitors and those visiting friends/family who stayed overnight in commercial accommodation (155 respondents) were asked, “How did you book your accommodation in Guernsey?” 41% booked their accommodation direct with the Guernsey accommodation provider (49% in 2023, 52% in 2024), as shown in **Figure 4.3.1**. 37% used another company such as Expedia, lastminute.com or booking.com to book their accommodation (32% in 2023, 34% in 2024), 8% booked their accommodation through a tour operator as part of a package (16% in 2023, 14% in 2024). 1% booked their accommodation through a tour operator but not as part of a package.

During 2025, 36% of leisure visitors and those visiting friends/family who stayed in hotels, guest houses, accommodation listed on Airbnb and similar online portals, self-catering units and campsites booked their accommodation in Guernsey 1, 2 or 3 months before arriving (41% in 2023, 44% in 2024), whilst 21% booked accommodation between 4, 5 or 6 months before arriving (26% in 2023, 20% in 2024), as shown in **Table 4.3.1**. 13% of visitors during 2024 booked more than 6 months before arriving (14% in 2023, 17% in 2024). 30% of visitors booked their accommodation less than 1 month before arriving, during 2025, (19% in 2023 and 2024).

**Figure 4.3.1 How did you book your accommodation in Guernsey?**



## 4.4 Visitor Survey\* - how much leisure visitors and those seeing friends and family spent on their visit


Leisure visitors and those visiting friends/family were asked “In total, how much did you and any other people you travelled with spend on your visit to Guernsey (including travel and accommodation)?” Please note visitor spend, as reported here, is on behalf of the party and not individual spend. The average party size of respondents to the Visitor survey during 2025 was 1.9 people. 26% of respondents reported their party spent £1,500 or more on their trip (including travel and accommodation), the equivalent figure for 2023 was 32% and for 2024 was 41%. A further 26% reported their party spent between £1,000 and £1,499 (25% in 2023 and 21% in 2024), 15% spent between £750 and £999 (17% in 2023 and 14% in 2024), 14% spent £500 to £749 (14% in 2023 and 10% in 2024) and 17% spent £250 to £499 (10% in 2023 and 2024). Only 4% of respondents reported their party spent less than £250 on their trip, as shown in **Figure 4.4.1**. Average length of stay for visitors during 2025, as reported in **Section 3.4**, was 4.6 nights.


**Figure 4.4.2** How would you rate each of the following in terms of value for money?

Leisure visitors and those visiting friends and family who stayed overnight in commercial accommodation (155 respondents in 2025) were asked to rate aspects of their trip in terms of value for money, as shown in **Figure 4.4.2**. 86% of respondents rated attractions as good or very good value for money (81% in 2023, 83% in 2024), 83% rated transport and/or vehicle hire as good or very good value for money (80% in 2023, 77% in 2024), 82% rated organised tours and/or activities as good or very good value for money (71% in 2023, 72% in 2024), 67% rated eating/drinking out as good or very good value for money (unchanged from 2023 and 2024) and 65% of respondents rated travel to and from the Island as good or very good value for money (56% in 2023, 52% in 2024).



A free text question was asked of leisure visitors and those seeing friends and family “*What was the most enjoyable aspect of your trip?*” Answers to this question have been grouped into themes. Percentages do not add up to 100% for this question as more than one reason could be provided. 37% of respondents said the most enjoyable aspect of their trip was the natural environment (unchanged from 2024), with many citing the scenery, the beaches, the peacefulness, the beautiful coastlines and pretty lanes as a highlight. 22% reported seeing friends and family as the most enjoyable aspect (23% in 2024). 18% reported the activities they undertook (25% in 2024), including cycling, coastal walks, sea swimming, running and visiting historic sites, as the most enjoyable aspect of their trip. A further 12% of respondents mentioned dining out (11% in 2024), with people enjoying the good selection of restaurants. 11% cited the friendliness of the people they met as the most enjoyable aspect and 10% of respondents cited the attractions of Guernsey, 9% in 2024, (including Hauteville House, Castle Cornet, the Little Chapel, the Underground Hospital, the Occupation Museum and open air events such as the West Show, the Cobo balcony concerts and the Liberation Day 80th anniversary).

An additional free text question was asked “*What was the least enjoyable aspect of your trip?*” Answers to this question have been grouped into themes. 21% of respondents said travel to/from the Island was the least enjoyable aspect of their trip (26% in 2024), with respondents citing delays and cancellations of aeroplanes and ferries, poor communication from carriers, weather-related uncomfortable plane and ferry journeys, poor experiences at Guernsey and origin airports, and a lack of direct travel links between Guernsey and their destination. 10% of respondents cited weather as the least enjoyable aspect (12% in 2024). A further 10% mentioned the cost of their trip (9% in 2024) including the cost of travelling to the Island, dining out, taxis and accommodation. 9% mentioned roads, including road closures, diversions, volume of traffic, lack of pavements/ cycle lanes and difficulty finding their way round the Island (14% in 2024).


## 4.6 Visitor Survey\* - how leisure visitors and those seeing friends and family planned their visit

Leisure visitors and those visiting friends and family were asked “When you were planning your trip and things to do in Guernsey, which (if any) of the following did you use?”. Percentages do not add up to 100% for this question, as respondents were able to select more than one option. 41% of visitors during 2025 used the VisitGuernsey website (41% in 2023, 45% in 2024) to plan their trip to Guernsey. A further 23% and 21% used review websites like TripAdvisor and other websites (24% and 18% respectively in 2023 and 28% and 24% in 2024). 37% used none of the options listed to plan their trip to Guernsey (37% in 2023 and 33% in 2024), as shown in **Table 4.6.1**.



All visitors responding to the online Visitor Survey were asked “Which of the following did you, or any of the people you travelled with, do during your stay in Guernsey?”, as shown in **Table 4.7.1**. Percentages do not add up to 100% for this question as respondents were able to select more than one option. Results have been weighted by purpose of visit to ensure the survey responses are representative of all visitors.


The most popular activity (undertaken by 85% of visitors leaving by aeroplane and ferry during 2025) was eating and/or drinking out (87% in 2023 and 2024), followed by visiting sites of natural beauty (including beaches) at 72% (74% in 2023 and 75% in 2024) and walking and/or running, undertaken by 62% of respondents (68% in 2023 and 2024). Over half of all respondents during 2025 went shopping (59%) and visited man-made attractions: museums, galleries, monuments etc (52%).

All visitors responding to the online survey were also asked “Which method(s) of transport did you use during your visit to Guernsey?”, as shown in **Figure 4.7.1**. Percentages do not add up to 100% for this question as respondents were able to select more than one option.

The most popular method of transport in 2024, used by 48% of all (excluding cruise and yacht) visitors was the bus, followed by own car/van at 26%, and taxis (used by 25% of visitors). Comparison between 2025, 2024 and 2023 reveals an increase in the percentage of visitors using taxis (22% in 2023, 24% in 2024, 25% in 2025) and a decrease in the percentage of visitors using their own car/van (31% in 2023, 29% in 2024 and 26% in 2025).

The visitor accommodation capacity in Guernsey and Herm can be monitored over time through the number of accommodation providers with active permits each year and the maximum capacity of each accommodation provider, as shown in **Figure 5.1.1** and **Table 5.1.1**.

Visitor accommodation capacity shows the maximum number of people that could be accommodated in permanent building structures, such as hotels, guest houses, hostels, self-catering units and other similar accommodation with an active boarding permit. Temporary structures, such as those provided by accommodation providers for glamping and camping are excluded from the capacity (for comparability with other jurisdictions). It should be noted that the capacity reported does not include accommodation that is publicly advertised (for example, via airbnb.co.uk or other booking portals), but does not have an active boarding permit.

The capacity of accommodation providers with an active boarding permit for the 2025/26 season was 4,767, as shown in **Table 5.1.1**, which is 43 people less, or 0.9% lower than the previous year (2024/25 boarding permit season) and 51 people less, or 1.1% lower than 2 years ago (2023/24 boarding permit season).

Each year additional visitor accommodation is provided by the campsites of Guernsey and Herm. **Table 5.1.2** indicates the maximum additional capacity provided by temporary glamping and camping structures during the summer season. For summer 2025, an additional 315 people could be accommodated in 62 units which include equipped tents, cabins, yurts and shepherd's huts. These figures do not include camping/ motorhome pitches where visitors provide their own accommodation. This information has been collected since 2023 to help give a fuller picture of visitor accommodation.

## 5.2 Visitor accommodation - availability

Each month, visitor accommodation providers with active permits are asked to provide data on the availability and occupancy of their accommodation units. The responses received during 2025 include different accommodation types and sizes and statistics for these months are accurate to at least plus or minus 2% (at a confidence level of 95%). The responses are scaled up by the total amount of visitor accommodation (with both an active boarding permit and an aligned building use type) in order to give figures for the whole Island. 2024/25 boarding permit information was used to scale up the figures for the first quarter of 2025. 2025/26 boarding permit information was used to scale up the figures for the second, third and fourth quarters of 2025.

Units are classified as not available for booking *only* if the whole site is closed; either seasonally (in a regular pattern) or for six months or more (for refurbishment, for example). Units are added into or taken out of the total (sum of open and closed units) if a site's use is officially changed via a successful planning application or if there have been physical changes to building(s).

Occupancy (see next page) is calculated as a proportion of the available units in each month i.e. a proportion of those that could be booked.

This approach is in alignment with methods used in other jurisdictions.

This information is only available from 2022 onwards, following changes to the way data is collected from accommodation providers.


**Figure 5.2.1 Availability of visitor accommodation**

**Table 5.2.1** and **Figure 5.2.1** show that there were 1,894 visitor accommodation units in Q4 2025. During Q4 2025 there were a number of visitor accommodation seasonal closures. The proportion of visitor accommodation units available to be booked was 97.3%, 96.4% and 93.6% in October, November and December 2025 respectively.

Occupancy is presented as a percentage of the number of available units (p22). As shown in **Figure 5.3.1**, there is usually a seasonal pattern in occupancy, with peaks in July, August or September and troughs in January each year. This pattern was severely disrupted in 2020 during the COVID-19 pandemic, but can be seen again in 2021 and 2022.

Temporary planning exemptions were introduced during the COVID-19 pandemic. From 25th March 2020, providers of visitor accommodation have been permitted to accommodate non-visitors and long-stay residents all year round, provided that the establishments revert to their usual use for visitor accommodation once the temporary exemptions cease to apply (on 28th February 2027). Exemptions allowing long-stay visitors would normally apply only to self-catering establishments during the Winter Let period from 1st November to 31st March each year. There was a wave of cases of the Omicron variant of COVID-19, which impacted on the ability to collect full data in March and April 2022.

Occupancy of open units in 2025 has increased from a low of 38% in January 2025 to a peak of 80% in September 2025. Since September 2025 occupancy has fallen. Specifically during Q4 2025 an occupancy of 60% was recorded in October 2025, 44% in November 2025 and 45% in December 2025. The average occupancy of open units in 2025 was 61% (56% in 2023, 59% in 2024).

Additional information began being collected in June 2023, which makes it possible to determine the percentage of units occupied by long-stay guests. Long stay occupancy was lowest in August 2025, when 6% of open units were occupied by long stay guests and highest in December 2025, when 43% of open units were occupied by long-stay guests. This means in December 2025 long-stay guests represented just over 19 percentage points of the 45% occupancy of open units in December 2025, which means if long stay guests were excluded from occupancy figure, the occupancy in December 2025 would be 25%.


## 6.1 Visitors - yacht trip visitors

Guernsey Marinas collect comprehensive information on the number of visiting yachts, the number of yacht passengers and the number of nights spent by visiting yacht vessels in Guernsey during each month, this information is displayed per annum in **Figure 6.1.1**. COVID-19 related requirements were put in place for people travelling into Guernsey in February 2020 and remained in place throughout 2021 with no non-essential travel allowed between 12th March 2020 and 20th May 2020 or between 14th January 2021 and 22nd March 2021. The requirements varied depending on the country of origin and vaccination status of the traveller. All COVID-19 related travel restrictions were lifted on 17th February 2022. As such, comparisons in this report are mainly drawn between 2023, 2024 and 2025.

As shown in **Table 6.1.1** the number of visitors travelling to Guernsey by yacht totalled 19,974 people in 2025, 3% higher than 2024 and 15% higher than 2023. The number of visiting yacht vessels during 2025 totalled 7,788 vessels and is broadly unchanged from 2024 (7,776 vessels) and 4% higher than 2023 (7,484 vessels).

The total length of stay by visiting yachts during 2025 was 14,393 nights - equating to an average length of stay of 1.8 nights per vessel. By comparison the total length of stay by visiting yachts during 2024 was 14,005 nights - equating to an average length of stay of 1.8 nights per vessel and 14,032 nights in 2023, equating to an average length of stay of 1.9 nights per vessel.

**Figure 6.1.1 Visitors by yacht**





## 7.1 Visitors - cruise ship visitors

**Figure 7.1.1 Visitors by cruise ship**



Guernsey Harbours collect comprehensive information on the number of cruise ship passengers that chose to visit Guernsey, the number of cruise ships and the total number of cruise ship passengers aboard each ship. COVID-19 related requirements were put in place for people travelling into Guernsey in February 2020 and remained in place throughout 2021 with no non-essential travel allowed between 12th March 2020 and 20th May 2020 or between 14th January 2021 and 22nd March 2021. The requirements varied depending on the country of origin and vaccination status of the traveller. All COVID-19 related travel restrictions were lifted on 17th February 2022. As such, comparisons in this report are mainly drawn between 2023, 2024 and 2025.

As shown in **Figure 7.1.1** and **Table 7.1.1** the number of visitors that came ashore in Guernsey by cruise ship totalled 28,397 people in 2025, 67% lower than 2023 and 26% lower than 2024.

There were 50 actual cruise ship visits during 2025, although 66 were planned. Poor weather was the reason for the cancellation of 16 cruise ships.


The total number of passengers on board cruise ships during 2025 totalled 34,432 people (82% of all passengers came ashore during 2025, a slightly lower proportion than 2023 and 2024).

## 8.1 Residents - main purpose of trip away from Guernsey

**Figure 8.1.1 Residents - main purpose of trip away from Guernsey**



Data is collected from a stratified sample of passengers departing Guernsey by aeroplane or ferry via a short interview-style survey. One of the questions asked of residents is what the main purpose of their trip away is. Survey results are applied to overall passenger volumes to give figures for the whole year.

In 2025, 55%, 135,962 residents reported the main purpose of their trip away from Guernsey was for leisure, 5% more than the 129,984 residents who reported they were travelling for leisure in 2023, and broadly unchanged from the 135,572 residents in 2024.

22% of all residents, 54,559 people cited they were seeing friends/family, 2% higher than the 53,681 who reported they were travelling to see friends/family in 2023 and 4% higher than the 52,678 residents in 2024.

9%, 23,076 residents were leaving on business (14% lower than 2023 and 8% lower than 2024) and 14%, 34,916 were leaving for other reasons (24% higher than 2023 and 21% higher than 2024). Other reasons include residents travelling for medical/hospital purposes, residents participating in sport and residents on a school trip/visit.

## 8.2 Residents - destination and length of trip away from Guernsey

Passenger exit survey questions include asking residents what their destination port is, whether this is their final destination port and how many nights they plan to spend away from the Island. Survey results are applied to overall passenger volumes to give figures for the whole year.


The majority, 75% of residents, 185,310 people were travelling to the UK in 2025, 1% more residents than in 2024 (in 2024 the equivalent figure was 76% of residents and 184,128 people).

11% of residents travelled to Jersey, 28,122 people; for 2024 this was 13% of residents and 30,976 people. The number of residents travelling to Jersey during 2025 was 9% lower than for 2024.


14% of residents, 35,082 people travelled elsewhere during 2025 (11%, 27,159 residents travelled elsewhere in 2024). The number of residents travelling elsewhere during 2025 was 29% higher than 2024.

Day trips accounted for 9% of all residents' trips during 2025. The average length of trip by residents during 2025 was 7 nights.

## 9.1 Methodology

Exit surveys are undertaken daily at the airport and harbour, with a random sample of departing passengers being interviewed. The proportions of resident versus visitor travellers are then applied to the actual numbers of total passengers (provided by the airport and harbour authorities) to determine the passenger composition of Guernsey's main air and sea routes. The survey is conducted using internationally accepted methodology.

In 2025, 21,740 completed interviews were conducted with individuals at the harbour and airport, who responded to the survey on behalf of their immediate travelling party. These interviews represented a total party size of 40,082 passengers, which is 8% of the total number of passengers departing Guernsey during 2025 (excluding those travelling within the Islands of the Bailiwick and those departing by cruise ship or yacht). All sample surveys are subject to a degree of statistical error. In 2025, there were 21,740 exit interviews conducted and it was found that, excluding cruise ship and yacht visitors, 47% of respondents were visitors. With a 95% confidence level, the margin of error is plus or minus 0.5%. In other words, there is a 95% probability that the proportion of departing visitors lies within the range of 46.5% to 47.5%. As the sample sizes decrease (for individual routes, purposes of visit and types of accommodation for example), so the margin of error increases.

Upon completion of exit surveys at the harbour and airport visitors were asked: *Would you be willing to give us some more feedback about your visit via an online survey, if I give you a link to follow? If so, you can enter a quarterly prize draw to win £100 in Amazon gift vouchers.* For those respondents who replied yes, a link/QR code was shown to the respondent to follow in order to take part. The Visitor Survey asks some more detailed questions about the activities undertaken and experiences of visitors to Guernsey. A much smaller sample of 274 people completed the Visitor Survey during 2025.

The statistics based upon Visitor Survey data represents 0.1% of all visitors to Guernsey during 2025 and 1% of all those who completed an exit survey at the airport and harbour. At a confidence interval of 95%, data presented from the Visitor Survey is reported with a 5.9% margin of error, which means the true result may lie within plus or minus 5.9 percentage points of the percentages published. Where numbers are based upon Visitor Survey data this is noted in the report.

Visitor Survey data which relates to all visitors has been weighted by purpose of visit according to the proportions presented in [Section 3.1](#), in order to be representative of all visitors. Where results are based on only business visitors or only leisure visitors and those seeing friends and family, results have been presented unweighted.
